

21 European countries:

Austria, Belgium, Czech Republic, Denmark, Finland, France, Germany, Greece, Hungary, Ireland, Italy, Netherlands, Poland, Portugal, Romania, Slovakia, Slovenia, Spain, Sweden, Switzerland, and the UK.

The Spectrum Database covers 33 European countries: EU-27 plus North Macedonia, Norway, Serbia, Switzerland, Turkey and the UK.
